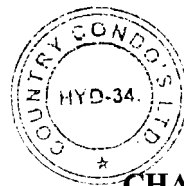

1. The Company has completed on 26<sup>th</sup> December, 2013 the dispatch of postal ballot forms along with postage prepaid business reply envelop to its members whose name(s) appeared on the Register of Members/List of beneficiaries as on 16<sup>th</sup> December, 2013.
  2. Particulars of all the postal ballot forms received from the Members have been entered in a Register separately maintained for the purpose.
  3. The postal ballot forms were kept under my safe custody in sealed and tamper proof ballot boxes before commencing the scrutiny for such postal ballot forms.
